## INFORMATION / NOTES

- The pit space fee amounts to a flat rate of € 115.00 per registered race car and is valid for the period from Thursday evening to Saturday after the end of the race at the respective event. In the event of late arrival (e.g. Friday) or early departure (e.g. due to DNF), no pro rata refund will be granted. The pit rent will be paid to the respective organiser (invoicing after the event).
- The maximum space in the paddock per applicant/team amounts to 60 m<sup>2</sup> for one (1) registered race car. For each additional registered race car, the applicant receives an additional (+) max. 30 m<sup>2</sup> of space, only for set-up and service vehicles, the maximum total area is 150 m<sup>2</sup>.
- Additional space can be booked on request and subject to availability. The fees can be found in the Organisational Regulations (4.1).
- The calculation of the areas used is based on the dimensions of the plot(s) occupied in accordance with the detailed "paddock plan".
- Delivery permits are available for a deposit of €100.00 at the gate in Stefan-Bellof-Str. (paddock entrance) and authorise loading and unloading in the paddock for 2 hours. Afterwards, the paddock must be left and the deposit will be returned. Non-authorized vehicles will be towed away at the expense of the owner/driver.
- A maximum of six (6) spaces is available for the racing vehicles in each box.
- All boxes have a total interior surface area of 125 m<sup>2</sup> (19.5 x 6.4 m) and are equipped with a toilet and washbasin.
- Each team receives the required number of gate entry passes on a Wednesday before the respective event, in case of an annual booking before the start of the season.
- All vehicles parked in the paddock are required to have a telephone number visible from the outside.
- Incorrect information: The applicant is liable for illegible information, incorrect information or unidentifiable drawings in the area of the requirements sketch. Penalties will be charged to the responsible person/applicant/team for not (properly) registered constructions.

### Paddock regulations from pit exit gate

Rescue route	7 m rescue route (must be kept clear at all times)
R-Row	per box, 2 x 18.5 m x 3.50 m parking space for set-up vehicles <b>Trailers/vehicles with extendable bays are NOT permitted in the "R-row"!</b>
1. Paddock route	One-Way street (must be kept clear at all times)
S-Row	2 x 18 m x 3.50 m parking area per box for set-up vehicles, service vehicles and tents
2. Paddock route	One-Way street (must be kept clear at all times)
I-Row	Industry row, as well as tent area from box no. 22/23 to box no. 33

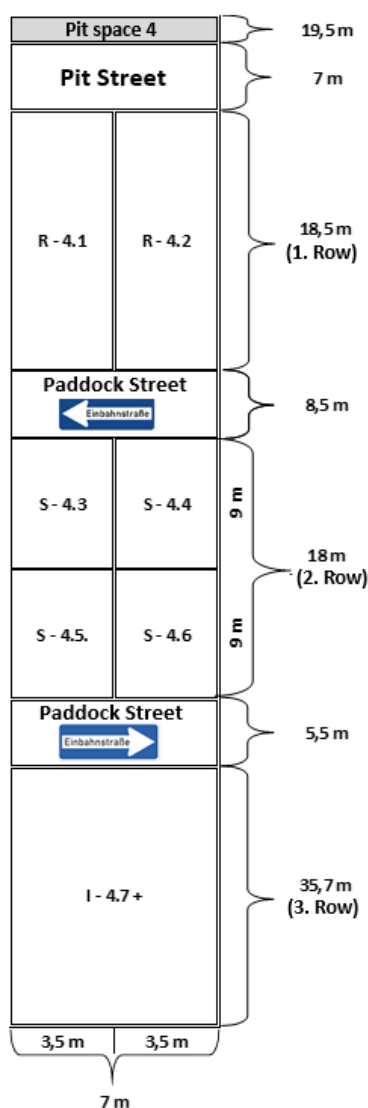
### Important note on temporary structures (tents/structures >75 m<sup>2</sup>):

Workshop tents that are attached to a semi-trailer or truck or that have a base area of more than 75 m<sup>2</sup> (the truck or semi-trailer is included in the base area) are temporary structures within the meaning of the "FIBauR, § 76 Para. 1 LbauO" Rhineland-Palatinate guideline for temporary structures. These structures must have a valid construction licence or inspection book. Ballasting required for the tent must be provided by the tent operator / participant. Checks will be carried out by the responsible authorities. The tent operator is liable for any penalties.
