## ACCREDITATION AGREEMENT FOR MEDIA REPRESENTATIVES

- §1 I am aware of the risks and dangers emanating from motor-racing events and undertake to abide unconditionally and immediately with the regulations and instructions (in written, verbal or visual form) issued by the organisers of the ADAC Nürburgring Langstrecken-Serie, the race control, the marshals, as well as the police and their representatives, and in particular not to enter restricted areas or safety zones.
- §2 I accept that I am acting at my own risk when leaving the areas generally accessible for spectators and the areas explicitly designated by the race control, even if staying there is tolerated by the organiser. Explicitly designated by the race control are: all the areas designated as spectator areas, the entire paddock and service area including all the connecting roads and ways and the pit area. I am aware, that staying in front of track boundaries (guard rail, concrete wall, etc.) in restricted areas or safety zones and obvious danger zones is strictly prohibited.
- §3 I take part in the event/s of the ADAC Nürburgring Langstrecken-Serie at my own risk. I declare with the cession of this media representatives' declaration that I waive any claims or rights to pursue action for damages in connection with the event/s of the ADAC Nürburgring Langstrecken-Serie against:
- the FIA, the DMSB, the DMSB affiliated and member organisations, the DMSW GmbH, their presidents, executive bodies, managing directors, secretaries general, representatives, staff and members,
  - the ADAC e.V., the ADAC district / regional clubs, the ADAC local clubs and the corporations associated with the ADAC, the DMV e.V., the AvD e.V., their presidents, executive bodies, managing directors, secretaries general, representatives, staff and members,
  - the organizer, promoter, series organiser of the ADAC Nürburgring Langstrecken-Serie, the VLN Sport GmbH & Co. KG, the VLN VV GmbH & Co. KG, their managing directors, executive bodies, representatives, staff and members
  - the organiser/s of the individual event/s of the ADAC Nürburgring Langstrecken-Serie, the officials and marshals and helpers, the circuit owners, the authorities' entities, racing services and all other persons involved with the organisation and implementation of the event/s of the ADAC Nürburgring Langstrecken-Serie,
  - the organisation responsible for the construction and maintenance of roads, and
  - the agents and other persons employed to perform an obligation, the legal representatives, the executive bodies, the representatives, the full-time employees and volunteers of all the above persons and entities as well as their members
  - the competitors, drivers, vehicle owners and their helpers,
- excluded of this are damages or harm to life, body or health resulting from the deliberate or gross negligent breach of duty – also by a legal representative or assistant of the group of persons released from liability – and other damages resulting from the breach deliberate or gross negligent breach of duty – also by a legal representative or assistant of the group of persons released from liability –. The disclaimer applies to claims for any legal reason whatsoever, so in particular to claims for damages based on contractual and non-contractual liability and to claims from tortuous acts. Implied exclusions from liability shall remain unaffected by the above non-liability clause.
- §4 The areas explicitly allocated by the organizer and / or the race control for the media reporting at the events of the ADAC Nürburgring Langstrecken-Serie are marked on the track map / the pothographers' map Nürburgring. I will study this map/s on every day of the event and will respect it.
- §5 I am aware that the use of TV and video cameras requires a written permission from the owner and administrator of the ADAC Nürburgring Langstrecken-Serie film and TV rights. The owner and administrator of the film and TV rights reserves the right to take legal action in the case of an illegal use of TV and video cameras. Filming permits for the events of the ADAC Nürburgring Langstrecken-Serie must be requested from the VLN VV GmbH & Co. KG.
- §6 I am aware that a breach of the above paragraphs results in the revocation of my media accreditation and can result in legal consequences. The disclaimer will take effect with the submission of this media representativs statement to all parties involved.
- §7 For safety reasons, the use of unmanned aircrafts (e.g. drones / microcopters) is prohibited in the events of the ADAC Nürburgring Langstrecken-Serie. The organizers of the ADAC Nürburgring Langstrecken-Serie and the DMSB reserve the right to punish a violation by imposing a fine of EUR 50,000. The organizer/s of the ADAC Nürburgring Langstrecken-Serie can grant exceptions, taking into account the legal requirements and regulations.
- §8 With reference to the processing of your personal data by the ADAC Nürburgring Langstrecken-Serie, reference is made in accordance with Article 13 of the DSGVO to the data protection declaration of the ADAC Nürburgring Langstrecken-Serie, through which the ADAC Nürburgring Langstrecken-Serie complies with the statutory information obligation.
