Important Information / Statement of the Applicant

The DMSB is a member of the FIA and thus authorized and obliged to enforce, throughout the territory of the Federal Republic of Germany, the FIA International Sporting Code (ISC) and all other regulations and provisions issued by the FIA and to draw up own regulations and provisions within the scope of its responsibility. The FIA ISC with Appendices, the Judicial and Disciplinary Rules of the FIA and of the DMSB, the Anti-Doping Regulations of the International and the National Anti-Doping Agencies (WADA/ NADA Codes) and the other regulations and provisions issued by the FIA/ the DMSB are printed and published in the DMSB Yearbook of Automobile Sport (www.dmsb.de/Downloadcenter/), in special prints, brochures or published online. They are available at the DMSB headquarters and on the DMSB website www.dmsb.de → Medien/Service. The publications can be purchased through www.dmsb.de. Applicants for a licence will receive the aforementioned sporting codes, regulations and provisions in advance upon request.

The FIA has reserved the right to alter the Code at any time and to periodically revise the Appendices (ISC Art. 19.2). The DMSB on its part also reserves the right to alter or to complete its regulations and sporting provisions. The regulations may anyhow also be altered or completed during the calendar year if it is considered necessary to maintain safety and public order in automobile sport, to keep the balance of performance and/or if a gap in the regulations is discovered. Changes and supplements to the regulations will be published in the DMSB publications or notified in writing. The participation in club sports events is regulated in the club sports regulations and in the standard regulations. Any such regulations are at all times available from the organizer upon request and they are published in the internet under www.clubsport-motorsport.de.

Important Information / Statement of the Applicant

Statement of the Applicant: With my signature, I expressly declare that

- I have taken note of the FIA International Sporting Code (ISC) with Appendices, the CIK Regulations, the FIA and the DMSB Judicial and Disciplinary Rules, the Anti-Doping Regulations of the International and the National Anti-Doping Agencies (WADA/ NADA Codes) and of the FIA and DMSB, the rules and all other provisions issued by the FIA, the CIK and/or the DMSB, in the latest versions respectively, as well as of the information and statements made on this application form and I agree that these sporting regulations, rules and provisions including the information and statements made on this application form become an integral part of the licence contract and that I am bound by them as well as that I will respect them.
- The DMSB and FIA jurisdictions, the officials/marshals and the organizers – each party within the scope of their responsibilities – are authorized, in addition to other procedures, to also inflict penalties for infringements of the sporting regulations, the rules, provisions and contractual obligations, as provided for in the ISC, the RuVO, the Regulations, Supplementary Regulations and other provision, irrespective of the right to pursue remedies as provided for in the ISC, the RuVO and the rules and that I accept and respect the decisions and sanctions taken by the FIA, the CIK, the DMSB, their Presidents, bodies, committees, courts and representatives.
- I am not entitled to claim any compensation of whatever kind against the DMSB, its member organizations, the Deutsche Motor Sport Wirtschaftsdienst GmbH, the bodies, managing directors as well as the vicarious agents, staff and members of the aforementioned bodies and persons, originating in connection with the issue of the licence, the refusal to issue the licence, the withdrawal, expiry or suspension of the licence, conditions made (where applicable), the refusal to give the authorization to take part in a competition abroad or of any other action or decision.

The disclaimer does not apply for damages or harm to life, body or health or any other damage resulting from the deliberate or negligent breach of duty, and not for any other damage resulting from the breach of a material contractual obligation committed by the group of persons released from liability. In the case of damages resulting from a slightly negligent breach of duty of a material contractual obligation, the liability for financial loss and for damage to property is limited to the typical foreseeable damage. The disclaimer applies to claims for any legal reason whatsoever, so in particular to claims for damages based on contractual and non-contractual liability and to claims from tortuous acts.

Herewith I confirm that

- the DMSB – notwithstanding its authority to control automobile sports by means of provisions and rules as well as by measures taken by its organs and agents, is, in accordance with § 315 German Civil Code, authorised to close gaps of the licence contract with the DMSB, to amend those and to give a final interpretation with regard to the contractual stipulations.
- I undertake not to use any substances or apply any methods as defined on the list of prohibited substances and methods of the WADA.
- All the specifications made to the physician for the delivery of the medical aptitude form and regarding my mental and physical condition and regarding former diseases, if applicable, are true and correct.
- In the case of an injury occurring or detected during an event or in the case of health detriment which could temporarily or permanently call into question my fitness to participate in automobile sport events, and under consideration of the possible safety risk which might result not only for myself but also for third parties, I release all treating doctors from their duty to treat medical record confidentially amongst each other and with regard to the clerk of the course, the chief doctor, the stewards, the chief medical officer, the DMSB doctors, coordination automobile sport and the insurance claim company. Your personal data are processed on account of a legitimate interest of the DMSB. The purpose is the protection of licence holders at sporting events. You can object to this processing at any time with an effect for the future.
